Renewable Energy Certificates (RECs) can be created by owners of small generating units such as solar panel (Photovoltaic) systems. RECs are produced under the Australian Government's Mandatory Renewable Energy Scheme (Renewable Energy Electricity Act 2000) which seeks to encourage additional renewable energy production and provides an added incentive for customers installing a renewable energy system. - I understand that I can claim RECs for a SGU in a single claim for 15 years or in blocks of 5 years for the life of the system. I understand I must register the RECs within 12 months of the system installation to make the single claim for 15 years.
- I must retain proof and receipts of the installation date of the life of the RECs
